What is Financial Assistance?

The National Capital Region YMCA-YWCA provides for the needs of children and youth who cannot afford the full cost of our programs. The Y is committed to being accessible to all and works hard to support those who may be in challenging financial situations. Please note that the YMCA-YWCA will provide financial assistance towards a maximum of two weeks of swimming lessons per child.

How Financial Assistance is Determined?

Financial assistance is determined using a sliding scale fee that is based upon your needs, financial capabilities and an agreement that is acceptable to both you and the YMCA-YWCA. We require supporting documentation and we consider special circumstances when providing assistance. Because the dollars available to provide financial assistance are limited, we will determine eligibility and percentage of financial assistance on an individual family basis.

How to Apply for Financial Assistance

If you require financial assistance, please complete the application form. This form should be submitted to the Aquatics Coordinator. Once your application has been received and reviewed, we will contact you to discuss the support the Y can provide and determine your payment options. Please note that all payments must be received by June 15, 2009.

An alternative to this application form is to have a community support professional write a letter on behalf of your family or group to indicate your need for sponsorship. This professional could be a social worker, child and youth worker or school principal.
